body or board of a Multi-State Co-operative Society, election and audit, settlement of disputes and appeals by quasi-judicial authorities and grant of exemption to the Multi-State Cooperative Societies from any of the provisions of the Act or Rules framed thereunder etc.

## Power projects pending for clearance

1628. SHRI M.A. BABY: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) the number of power projects pending with Government for final clearance:
- (b) the details thereof, with the date of receipt, stage of consideration, the status and the final decision, if any;
- (c) whether Government have decided to liberalise the norms for granting clearance to projects; and
  - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (CAPT. JAI NARAIN PRASAD NISHAD): (a) A total of 38 power projects including one hydro power project are awaiting environmental clearance as on 30th November, 1996.

- (b) Assessment of the projects referred for environmental clearance is completed within a period of 90 days from receipt of requisite documents and data from the project authorities and decision is conveyed within 30 days thereafter. Duration of pendency of 38 power projects varies between one month to one year due to normal processing and non submission of requisite environmental data and Management Plan in some cases.
- (c) and (d) Modalities for delegation of powers to State Governments for according environmental clearance to thermal power projects are under finalisation.

## Implementation of Mid-day meal scheme

- (c) A decision on environmental clearance is taken within 90 days of receipt of complete information from a project proponent.
