(d) what other steps will be taken to modernise Air Traffic Control in Delhi and other International Airports?

THE MINISTER OF CIVIL AVIATION (SHRI C.M. IBRAHIM): (a) and (b) No, Sir.

(c) and (d) Secondary surveillance radars have already been installed at Hyderabad and Thiruvananthapuram. Modernisation of Air Traffic Control System of Mumbai and Delhi Airports has been taken up at an estimated cost of Rs. 423.89 crores. The equipment is being installed and tested and is likely to be commissioned by June, 1997. The Air Traffic Control Systems at Calcutta. Chennai, Guwahati and Ahmedabad airports are being augmented and likely to be completed by December, 1997. In addition, communication and navigational facilities at other airports of the country are being updated/modernised in a phased manner.

Complaints by exporters about malpractices in Customs Department

1877. SHRI SURYABHAN PATIL VAHADANE: Will the Minister of FINANCE be pleased to state:

- (a) Whether it is a fact that several exporters have complained about the malpractices in the Customs Department regarding some drawback or any other facility given to them;
- (b) if so, the details of the complaints; and
- (c) what necessary steps have been taken to attend to these complaints and to prevent such things in future?

THE MINISTER OF FINANCE (SHRI P. CHIDAMBARAM) (a) to (c) Some complaints have been received exporters regarding delay in processing of documents, malpractices and different interpretations by different officers. Enquiries are conducted on the complaints and where evidence of wrong doing is found, action is taken. Each Custom House has a Public Grievance Committee for redressal such

complaints and senior officers immediate remedial action as and when matter is brought to their notice. Besides. watchdog committees chaired Commissioner/Addl. Commissioner have instituted to look into such grievance. An officer of the rank of Assistasnt and Additional Commissioner in each of the Custom houses and an officer of the level of Joint Secretary in the Ministry has been designated as the Nodal Officer for attending to such complaints/grievances. Regular monthly Interministerial meetings also take place to sort out the issues relating to interpretation of licensing policy/ regulations between Customs and DGFT.

Encouraging Voluntary Blood Donation in Gujarat

THE MINISTER OF STATE OF THE MINISTRY OF THE HEALTH AND FAMILY WELFARE (SHRI SALEEM IABAL SHERVANI): (a) to (c) To encourage voluntary blood donation in the country, Government have launched a massive motivational campaign through one-to-one mass-media and communication at all the Blood Banks. The campaign gets intensified around Ist October each year being the National Day for Voluntary Blood Donation when a large number of activities directed towards Voluntary Blood Donation are undertaken. Gujarat State has also drawn up a suitable programme for generating the required quantity of blood through Voluntary Blood Donation Programme and discouraging professional donors.
