CHIDAMBARAM): (a) to (c) Government have initiated a total review of Sick Industrial Companies (Special Provisions) Act, 1985 (SICA) and the working of the Board for Industrial and Financial Reconstruction (BIFR) with the intention to bring a new Bill in the Parliament.
