(c) The train actuated radio based audiovisual alarm system designed and developed by M/s Bharat Electronics Limited was tried out at two level crossings near Bangalore. The outcome of the trials on these two level crossings has been encouraging. Further, extended trials on nine more level crossings are underway on Northern, Southern and South-Central Railways.

## Construction of Overbridge/Subway at Gate No. 245-A, Bhatinda

2320. SHRI E. BALANANDAN: Will the Minister RAILWAYS be pleased to state:

- (a) whether Government have received representations dated 20-8-96, 11-9-96 and 29-10-96 from "Khooni Railway Fatak Hatao Sanghursh Committee, Bhatinda (Punjab)" demanding removal of Railway Gate No. 245-A situated near the Paras Ram Nagar, Bhatinda and construction of an overbridge or subway:
  - (b) if so, the details thereof;
- (c) whether Government are taking steps to meet the public demand; and
- (d) if so, the time by which it is likely to be taken up and completed?

THE MINISTER OF RAILWAYS (SHRI RAM VILAS PASWAN): (a) to (d) Yes, Sir. The Committee has demanded replacement of level crossing No. 245-A at Km. 297/10-11 on Bhatinda-Ferozepur section by a Road over/ underbridge. Railways construct Road over/ underbridges in lieu of busy level crossings on cost sharing basis, the proposal for which are made by the State Govt. agreeing to bear their share of cost. No proposal for construction of this bridge has been received from State Govt.

(b) and (c) The life trustees in the Indira Gandhi National Centre for Arts were appointed on the basis of amendment of the Trusteeship Deed of the Trust in accordance with the provisions contained therein. The Trust functions in accordance with the Deed and the rules made thereunder. The Trust in its meeting held on 18.5.1995 has incorporated five exofficio trustees including two union Ministers, Chairperson of University Grants Commission. Chairperson of one of the National Akademies and Vice Chancellor of a University of Delhi.

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT FORESTS (CAPT. JAI NARAIN PRASAD NISHAD): (a) to (c) Database on analysis about the consumption level if the developed and developing countries is not comprehensive. The data available are limited to only some economic sectors. The Government takes into consideration all relevant factors on environmental issues while dealing with World Trade Organization.
