(b) the details of the application of the methodology in respect of Kendriya Vidyalayas of Lucknow and Bhopal region, Vidyalavawise?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) and (b) Posts of Post Graduate Teachers including Post Graduate Teacher Commerce are sanctioned based on the assessment of number of periods per week for classes XI and XII as also for the lower classes. Accordingly the staff strength for Kendriya Vidyalayas of Bhopal and Lucknow regions having commerce stream has been sanctioned. In Bhopal region there are five Kendriya Vidyalayas with one, and two Kendriya Vidyalayas with two Post Graduate Teacher (Commerce) and in Lucknow Region there are seven Kendriya Vidyalayas with one, and three Kendriya Vidyalayas with two Post of Post Graduate Teacher (Commerce).

THE MINISTER OF AGRICULTURE (SHRI CHATURANAN MISHRA): (a) and (b) No. Sir. There is no such proposal. NSC is not facing a liquidity crunch.
