## Death of Children due to Malnutrition in Melghat, Maharashtra

- (a) whether Government's attention has been drawn to the report captioned. "Malnutrition snuffs out 500 lives in Melghat", Amravati (Maharashtra);
- (b) if so, whether Government have verified the reports of death of hundreds of children in the Melghat tribal-belt due to malnutrition; if so, the details thereof; and
- (c) the Central aid, if any, given to rid the tribal belt of the malady, indicating both shortterm and long-term measures taken by Government?

- MINISTER OF THE HUMAN RESOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) Government is aware of the
- (b) According to a report of Government of Maharashtra, a total of 212 deaths of preschool children occured during the period May to July, 1996 in Amravati district The causes of deaths have been identified, as high-Fever pneumonia, acute respiratory infections, dysentry. diarrhoea, low birth weight etc. The children who died belonged to all grades of nutritional status ranging form normal to severe malnutrition. A field visit made by DWCD to Amravati district during September 22-25, 1996 confirmed deaths of pre-school children.
- (c) The Department of Women & Child Development is involved in the implementation of **ICDS** project which provides supplementary nutrition among other services to the pre-school children. There are 14 ICDS projects in district Amravati. Of these, 10 ICDS projects including the two in Dharni and Chikhedara are fully operational. During the current year an amount of Rs. 101.92 lakhs has already been released to the State, in first two instalments, towards the ICDS projects in District Amravati.
