Interested journalists often approach the Ministry to cover visits by the Minister of External Affairs to foreign countries. These visits are facilitated by the Ministry and assistance for visas, appointments, hotel bookings as well as transportation is provided to them. Relevant background information disseminated to these journalists and the host governments are requested to extend normal courtesies which include inter alia-accreditation if required, briefings, access to venues and interviews with relevant personalities. If the Minister is taking a special flight, journalists are taken on board on a space available basis. The reputation of the newspaper/ agency, its reach; its interest in the area being visited; its impact; and the overall spread Or coverage generated-are account factors taken into examining the composition of the media party. Likewise local correspondents of newspapers/agencies based abroad often wish to cover EAM's visits to their regions and the Ministry/Missions assist them in a similar manner. Except in the case of air travel by special aircraft, journalists are advised that expenditure on such visits is to be borne by them or their parent organisations.

### Guidelines for foreign Debt incurred by Indian Telecom Companies

This is further subjected to any limitation that may be imposed by Ministry of Finance, Government of India.

(c) and (d) The bidder companies for the above services have not submitted any details on the quantum of external borrowings for their projects.
