Loans and subsidies under IRDP

*409. SHRI AHMED PATEL: Will the Minister of RURAL AREAS & EMPLOYMENT be pleased to state:

- (a) whether any loans and subsidies under IRDP are provided to families living below poverty line in rural and tribal areas, for accuiring income generating assets;
 - (b) if so, what are the details thereof;
- (c) how many tribal and other families living below poverty line were given such loans and subsidies during the last three years in Gujarat, year-wise and district-wise; and
- (d) what other measures are being taken by Government in respect of such families in the country, particularly in Gujarat?

THE MINISTER OF RURAL AREAS AND **EMPLOYMENT** (SHRI K. YERRANNAIDU): (a) and (b) The Integrated Rural Development Programme (IRDP) aims at providing loan and subsidy to families living below poverty line to enable them to acquire income generating assets. It is stipulated that 50% of beneficiaries should belong to Scheduled Caste and Scheduled Tribe families. The total amount of loan and subsidy disbursed to poor families as well as ST families in rural areas under IRDP is given in Statement-I (See below)

(c) The total number of tribal families and other poor families covered under IRDP in Gujarat during the last three years is given in statement-II. (See below) District-wise physical 29

coverage under IRDP is being monitored by this Department only since last year. The total number of families assisted and ST families benefitted under IRDP in various districts of Gujarat during 1995-96 is given in statement-III. (See below).

(d) Families living below the poverty line in rural areas throughout the country, including Gujarat are being assisted through a number of self and wage employment programmes of this Department. Besides IRDP, the programme for Training of Rural Youth for Self-Employment (TRYSEM), the Development of Women and Children in Rural Areas (DWCRA), the Tool Kits Programme, the Jawahar Rozgar Yogana, the Employment Assurance Scheme, the Indira Awaas Yojana and the Million Wells Scheme also aim at improving the living standard of the rural poor including tribals.

(b) The cost of the feasibility study has been borne by the Oman Oil Company.

(c) No such proposal has been received from any insurance company. The Oman Oil Company has indicated that the estimated cost of the project is around USD 5 billion.
