The guidelines for Watershed development also provide for utilisation of 50% of the funds released under the Employment Assurance Scheme (EAS), on area development on watershed basis in the blocks covered under this scheme. Allocation under basis scheme is shared between Centre and States on 80:20 basis. Total Centre releases during 1995- 96 under this scheme were Rs. 1,70,569.00 lakhs.

(d) to (f) No separate body for monitoring the progress of development of watershed projects has been step up in this Ministry. The financial performance and physical achievements of watershed projects developed under DPAP and DDP are monitored through monthly and quarterly progress reports sent by the State Government in respect of projects taken up by each District Rural Development Agency (DRDA). Qualitative monitoring is done by the Area Officers of the Ministry through field visits in the States.

Physical and financial performance of the projects developed under IWDP, is monitored through quarterly reports. In addition independent evaluators are appointed after two monsoons to evaluate the work of each project. Besides the above, progress of projects is also monitored through field visits by Senior Officer of the departments of Wastelands Development.
