(b) the details of persons waiting for telephone connections under the Telephone Exchange at Nalanda; including its total installed capacity and since when; and

(c) by when Government propose to issue connections to all the wait-listed persons?

THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VARMA):  
(a) 1423.

#### **Capacity of Ordnance Factories**

10. SHRI PREM CHAND GUPTA: Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that most of the Ordnance Factories are running much below their installed capacity and have, as a result been suffering losses;

(b) if so, the measures Government propose to take such as diversifying their manufacturing activities; and also export, for increase in the utilisation of their capacities; and

(c) whether Government are thinking of making each Ordnance Factory, a separate profit centre?

**THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI N.V.N. SOMU)** (a) to (c) The capacity in some ordnance factories is not fully utilised due to—

- (i) fluctuations in demand for products.
- (ii) limitation of funds.
- (iii) some excess capacity having been deliberately created to respond to surge requirements in emergencies.

To improve utilisation of their capacities, the spareable capacities are deployed for diversification for civil market and export, wherever possible, after fully meeting the requirement of the defence forces.

Each ordnance factory is an independent business/production centre already. The ordnance factory organisation as a whole works on no profit no loss basis so far as the production for the armed forces is concerned.

#### **Signing of Licence Agreement for Basic Telephone Services**

**11. SHRI SATISH AGARWAL:** Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether it is a fact that no Licence Agreement has been signed for basic telephone services even though tenders for these services were invited earlier last year;

(b) if so, the reasons for the delay; and

(c) the time frame for signing the Licence Agreements for all the circles?

**THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VARMA):**(a) Yes, Sir.

(b) Seven Indian registered companies were issued Letters of Intent (LOIs) for Basic Telephone Service and only five of them have accepted the LOIs. The Government has taken appropriate steps to resolve a number of issues

raised by these companies keeping in view the provisions in the tender conditions as well as speedy implementation of National Telecom Policy. None of these companies, however, has paid the first year's licence fee which is the prerequisite for signing the Licence Agreement.

(c) Out of the ten LOIs issued so far by Govt. in March, 1996, five LOIs stand accepted in October, 1996 and shall be converted into Licence Agreements soon after the receipt of requisite Licence fee. The cases relating to remaining five LOIs are subjudice in the High Court of Delhi.
