THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (c) Kendriya Vidyalayas are not opened District-wise; they are sanctioned on the basis of proposals received from the sponsoring authorities fulfilling the norms prescribed for the purpose. 37 Kendriva Vidyalayas have been opened in Puniab so far

Navodaya Vidyalayas scheme envisages opening of One Navodaya Vidyalaya in each District of the Country depending upon suitability of proposals from the State Governments including offer of land free of cost, rent free temporary accommodation and other infrastructural facilities as per Navodava Vidyalaya Samiti norms. Navodaya Vidyalayas have been opened in 11 District of Punjab.

## Sustainable prawn farming

MINISTER OF THE **AGRICULTURE** (SHRI CHATURANAN MISHRA): (a) and (b) To develop prawnshrimp farming as a sustainable, eco-friendly and socially acceptable activity in the country, the Government of India have issued Guidelines to all the Coastal States and Territories. The Departments of Fisheries and other agencies of the State Governments such as the State Pollution Control Boards are monitoring the implementation different aspects of the guidelines.

(c) During 1995-96. Scientists from the Central Institute of Brackish-Water Aquaculture (CIBA),
