Hike in Prices of Fertilizers in Kerala

297. SHRI JOY NADUKKARA: Will Minister of CHEMICALS FERTILIZERS be pleased to state:

- (a) whether it has come to the notice of the government that in Kerala, the prices of fertilizers have gone up as the fertilizer companies are not availing subsidies and are selling fertilizers for prices fixed at their fancy; and
- (b) whether Government propose to take steps to ensure that the agriculturists of Kerala get the benefit of subsidy on fetilizers?

THE MINISTER OF STATE OF THE MINISTRY OF CHEMICALS FERTILIZERS (SHRI SIS RAM OLA): (a) and (b) The maximum retail price of decontrolled fertilizers fixed by the Government of Kerala for Kharif 1996 were provisionally extended to Rabi 1996-97. After negotiations with the manufacturers/suppliers in the context of increased cost of production/procurement and distribution, the prices were revised with effect from 1.11.96. During the period from 1.10.96 to 30.10.96, FACT has sold its product, Factomphos, without availing of the benefit of the Special Concession Scheme.
