### Rise in Prices of Milk

\*43. SHRI BHAGABAN MAJHI: Will the Minister of ANIMAL HUSBANDRY AND DAIRYING be pleased to state:

(a) the reasons for rise in the prices of milk in the country;

(b) whether Government have a proposal to launch white revolution in the country;

(c) whether prices of milk can be regulated and the price increase could be arrested thereby; and

(d) if so, the steps taken by Government in this regard?

THE MINISTER OF STATE OF THE DEPARTMENT OF ANIMAL HUSBANDRY AND DAIRYING (SHRI RAGHUVANSH PRASAD SINGH): (a) The increase in the prices of milk has followed the general price trend in the economy.

(b) With the objective of achieving self sufficiency in milk production. Operation Flood Scheme was implemented between June 1970 to Dec. 1995. In the Non-Operation Flood, Hilly and Backward areas the Integrated Dairy Development Project is being implemented.

(c) and (d) Control Orders are issued under the Milk and Milk Product Order imposing restriction on the movement of liquid milk and/or manufacture of milk products in order to increase the availability of liquid milk during periods of shortage with consequential impact on its price.
