THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN OF THE **MINISTRY** HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (c) The National Policy on Education 1986 as revised in 1992 states the resolution of the Government to provide free and compulsory education of satisfactory quality to all children upto 14 years of age before we enter the twenty first century. The Programme of Action (PCA) 1992, to the policy, provides the broad frame work to achieve these policy objectives. Within the framework, the Government has initiated a number of Centrally Sponsored Programme which include Operation Blackboard, Teacher Education, Non Formal Education, and Mid-day Meals Programme.

THE MINISTER OF STATE OF THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI SIS RAM

- OLA): (a) and (b) As per the Detailed Feasibility Report, the cost of the Oman India Fertilizer Project is now estimated at US\$ 1106 million. The earlier estimate of US\$ 897 million was based on preliminary studies. The escalation in the estimated project cost is mainly on account of provision of reserves for debt servicing and increase in financing fees, project management expenses and capitalised interest.
 - (c) Yes, Sir.
- (d) KRIBHCO and **RCF** accepted the proposal of Oman Oil Company that the operation and maintenance [O&M] of the fertilizer plant may be managed by the Joint Company [JVC] KRIBHCO and RCF second the O&M personnel to the JVC under a Personnel Supply Agreement. KRIBHCO and RCF have also agreed to provide technical services to the JVC under a Technical Services Agreement, KRIBHCO and RCF consider this arrangement to be more advantageous than an O&M contract.
