THE MINISTER OF FINANCE (SHRI P. CHIDAMBARAM): (a) to (c) The fiscal deficit for the current year 1996-97 (RE) is Rs. 62,266 crore which works out to 5% of GDP. The Government would endeavour to contain the fiscal deficit by maximising receipts and controlling expenditure.
