THE MINISTER OF STATE OF THE MINISTRY OF **PLANNING** AND PROGRAMME IMPLEMENTATION AND MINISTER OF STATE OF THE MINISTRY OF SCIENCE AND TECHNOLOGY (SHRI YOGINDER K. KLAGH): (a) Yes, Sir, CSIR is the rimary independent source offering U&D results to the Indian industry. It erves the industry through diverse ways ch as contract R&D technology licenc-ig, technical services, consultancy ser-ices etc.

CSIR has already forged alliances with bex industry organisations in the country or dissemination of information on tech-alogy through interactive meetings, con-rences and expositions.

- (b) Yes, Sir, CSIR has contacts with >e State Governments through interac-on at various levels; State S&T Coun-Is, CSIR laboratories and Polytechnolo-' Transfer Centres (PTCs) set up in illaboration with State Governments.
- (c) In 1996/97 a scheme has been traduced where every rappee earned by e CSIR on a commercial basis is atched by the Government. DG, CSIR

also a Member of the Technology evelopment Board set up in 1996.

## Amendment to the Urban Land (Ceiling & Regulation) Act, 1976

## 705. PROF. RAM KAPSE: SHRI RAJ NATH SINGH:

Will the PRIME MINISTER be pleased to refer to answer to Starred Question 222 given in the Rajya Sabha on the 25th July, 1996 and

- (a) whether the details of the proposed amendment to the Urban Land (Ceiling and Regulation) Act, 1976 have been worked out, taking into consideration the available infrastructure to meet housing programmes; and
- (b) if so, by when Government propose to introduce the Bill?

THE MINISTER OF STATE IN THE MINISTRY OF **URBAN AFFAIRS** AND **EMPLOYMENT** AND OF MINISTER **STATE** ΙN THE MINISTRY OF PARLIAMENTARY AFFAIRS: (DR. U. VENKATESWARLU): (a) and Government of India is considering proposals to amend the Urban Land (Ceiling and Regulation) Act, 1976 in order to make it more workable and effective by shifting its thrust from acquisition to development primarily for housing. The State Government have been requested to give their suggestions regarding amendments to the Act which are still awaited. Amendment proposals will be finalised only thereafter.

## Mismanagement and **Technical Deficiencies in DDA**

- SHRI SURYABHAN PATIL VAHADANE: Will the PRIME MINISTER be pleased to state:
- (a) whether Government's attention has been drawn to the news item published in the Hindi daily Dainik Jagran of 4th August, 1996 (Delhi edition), regarding mismanagement and technical deficiencies in the DDA, causing huge financial losses by awarding huge contract to an inexperienced contractor;

- (b) whether it is also a fact that this loss has already been brought to notice by a CAG report; and
- (c) if so, what action has been taken by Government against this malpractice in DDA and the erring contractor?

THE MINISTER OF STATE OF THE MINISTRY OF **URBAN AFFAIRS EMPLOYMENT** AND AND OF ΙN THE MINISTER STATE **MINISTRY** OF **PARLIAMENTARY AFFAIRS** (DR. U VENKATESWARLU): (a) Yes, Sir.

- (b) In paras 56 and 57 of report No. 3 of 1996, the CAG has pointed out the following:
  - (i) Overpayment of Rs. 24.92 lakhs to contractor towards security advance and cost of materials in respect of construction of 280 Dwelling units of Cat. II and III alongwith 168 scooter garrages in pkt. F & G Sarita Vihar, Group-I & II.
  - (ii) Wasteful expenditure of Rs. 22.11 lakhs in respect of augumentation of water supply of pkt. 5 & 6, Sector-B of Vasant Kunj.
- (c) The -DDA has taken actionimposed penalties on the defaulting Officers as follows:—
  - (1) Reduction by three stages in the present pay scale for two years in respect of an Executive Engineer.
  - (2) Reduction to the lowest grade for a period of 5 years which will not effect future increment in respect of an Assistant Engineer.
  - (3) Reduction to the lowest grade for a period of 3 years in respect of two JE's.
  - (4) Reduction to the lowest grade for a period of two years in respect of an Assistant Engineer.

The erring contractor who executed the work has since been debarred from further tendering in DDA. A FIR was lodged with the police. The contractor

approached Hon'ble High court which has appointed an Arbitrator. The Arbitrator is yet to publish his award. DDA has approached the Hon'ble High Court to intervene in the matter for issue of suitable directions. The matter is subjudice.
