Hence it is too early to make an assessment of deficiency in the financial resources for the Ninth Plan.

(c) and (d The Central Government account cut down the budget of the States on Account of not meeting the originally approved-plan target; but the Planning Commission has been revising, the approved plan outlay downward in those cases where resosurces availability of
