THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM & NATURAL GAS (SHRI T.R. BAALU): (a) No, Sir.

- (b) In order to facilitate the availability of petrol/diesel to the consumers in Andhra Pradesh, 80 retail outlet dealerships have been included in the Marketing Plan for 1993-96. Necessary action has also been initiated by the oil companies to put up these outlets in accordance with the established procedure. In addition, 19 retail outlet proposals have been included in the draft Marketing Plan for 1996-97 for Andhra Pradesh. It generally takes 6—12 months for commissioning of a retail outlet form the date of interview.
- (c) and (d) Retail Outlets are opened at places including those in rural areas

which meet the volume distance norms followed by the Oil Industry. Accordingly, 9 retail outlets have been included in the Marketing Plan 1993—% and 4 retail outlet in the draft Marketing Plan 1996-97 for the rural areas in Andhra Pradesh.
