## 10% Return from State PSUs

623. SHRI SATISH AGARWAL: Will the Minister of PLANNING AND PROGRAMME IMPLEMENTATION be pleased to state:

(a) whether Government's attention has been drawn to the news-item under the caption "Plan panel seeks 10% return from State PSUs" appearing in the Business Standard of 24th October, 1996;

(b) if so, the details of guidelines issued in this regard; and

THE MINISTER OF STATE OF THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI YOGINDER K ALAGH): (a) to (c) Yes Sir. The guidelines issued by the Planning Commission in this regard indicated that in so far as Public Sector Undertaking (PSUs) are concerned, the commercial PSUs should be asked to raise their- own resources without unduly depending on Plan support and specific plans should be evolved for them to yield returns of at least 10 per cent on existing equity and loans. The State Governments are expected to follow these guidelines while assessing the resources for, formulating Ninth Plan.
