मानव संसाधन विकास मंत्रालय में शिक्षा विभाग में राज्य मंत्री (श्री मुही राम सैकिया): (क) से (घ) राष्ट्रीय शिक्षा नीति. 1986 में शिक्षा के सम्पर्ण विकास के लिए दिशा-निर्देश हेत विस्तृत कार्य ढांचा और इसके विभिन्न प्रस्तावों के आयोजन, कार्यान्वयन और निधियन के लिए विशेष जिम्मेटारियों को निर्धारित करने वाली कार्य योजना का प्रावधान है। कार्य ढांचा अभी भी प्रासंगिक है। तथापि. कार्यान्वयन के दौरान हुए अनुभव और अन्य विकासों को ध्यान में रखते हए वर्ष 1990-92 के दौरान आचार्य राममर्ति की अध्यक्षता में गठित राष्ट्रीय शिक्षा नीति पुनरीक्षा समिति (एन.पी.ई.आर.सी.) और एन. जनार्दन रेडडी की अध्यक्षता में नीति पर गठित केन्द्रीय शिक्षा सलाहकार बोर्ड (केब) समिति द्वारा वर्तमान नीति की समीक्षा की गई। तदनुसार, संशोधित नीति निर्धारणों और संशोधित कार्य योजना 1992 को क्रमश: 7 मई, 1992 और 19 अगस्त. 1992 को सदन के सभा पटल पर रखा गया था। अब कार्यान्वयन तथा शिक्षा के लिए संसाधनों को बढाने पर बल दिया जाएगा।
