Action plan to provide gainful employment in khadi and village industries sector

THE MINISTER OF INDUSTRY (SHRI MURASOLI MARAN): (a) and Yes, Sir. Based on recommendations of the High Power Committee, KVIC is implementing the Rural **Employment** Generation Programme (REGP) to create 2 million additional employment in the country through development of khadi and village industries. The programme includes (1) District Special **Employment Programme**

- (2) 125 Block Development Programme,
- (3) National Programme on Leather, Handmade paper, Beekeeping and Pottery and (4) Special Projects in thrust

areas. In Gujarat, three districts namely Banaskhantha, Panchmahl and Kutch have been identified for the District Special Employment programme and 6 blocks, namely Dharampur, Dhanduka, Jasdan, Megraj, Savarkundla and Desada have been selected for the Block Development Programme. In addition to this, a few projects are also being taken up.
