2438. SHRI NILOTPAL BASU: SHRI BRATIN SENGUPTA: Will the Minister of LABOUR be pleased to state:

THE MINISTER OF LABOUR (SHRI M. ARUNACHALAM): (a) and (b) A Scheme for Employees' Participation in Management is operating since 1983 in all Central Public Sector Undertakings except those undertakings which are specifically exempted from the operation of the scheme. All Departmentally run undertakings of the Central Government are also excluded from the scheme.

The scheme envisages constitution of bipartite forums at the shop and plant levels. In enterprises considered suitable, also provides for board level participation. The Scheme provides for bipartite of consideration certain workconcerning related issues production, quality, technological targets, improvement, safety, welfare measures, environmental issues, absenteeism, financial performance of the enterprise etc.

Irregularities in the disbuTsement of loans under PMRY in the States of Bihar and Uttar Pradesh

2439. SHRI JANARDAN YADAV: Will the Minister of INDUSTRY be pleased to

- (a) whether there are wide spread irregularities in the disbursement of loans under the PMRY in the States of Bihar and Uttar Pradesh;
- (b) if so, whether a large number of loan applications are being turned down by Banks due to which the PMRY is proving to be a flop; and
- (c) if so, action taken/proposed to be taken to ensure loans to needy unemployed persons in these States?

THE MINISTER OF INDUSTRY (SHRI MURASOLI MARAN): (a) As per the reports received from States of Uttar Pradesh and Bihar, widespread irregularities in the disbursement of loans under Prime Minister's Rozgar Yojana have not been reported.

- (b) Banks may turn down cases recommended by Task Forces on their detailed scrutiny. While the performance of Bihar is not to the expected level, performance in Uttar Pradesh has, on the whole, been satisfactory.
- (c) It is an on going effort of implementing agencies to see that the loans are given to the deserving unemployed persons under the Prime Minister's Rozgar Yojana as per the parameters of the scheme.

THE MINISTER OF FOOD AND MINISTER OF CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI DEVENDRA PRASAD YADAV): (a) The total capacity of godowns hired by Food Corporation of India as on 31.10.96 from private

godown owners in Punjab and Haryana is 15.68 lakh tonnes and 2.73 lakh tonnes respectively. At present the rates of rent for private godowns are within the ceiling limits of 55 paise and 62 paise per sq. ft. per month for godowns in rural and urban areas respectively.

- (b) The names of private godowns owners whose agreements have expired are given in the enclosed statement *[see below]*. In cases where rent has not yet been fixed, it is being paid on ad hoc basis for the present.
 - (c) Yes, Sir.
- (d) Private Godown Owners Association in their representation has demanded enhancement of rent. The Food Corporation of India decide on such matters keeping in view, among other things, such representations also, from time to time.
