were technologically successes. Their failures on the economic front were however because of the need to keep prices at the lowest possible level. The pricing adopted consciously fixed the prices of BCCL at less than the economic prices,. The Govt. have recently deregulated the prices of coking coal which is the major product of BCCL in order to enacle the company to realise the true value of coal. On the second specific point relating to the female workforce in BCCL, they are mainly deployed in sidings and manual quarries. With the increase of mechanisation in order to enable faster despatches, manual workers are being rendered surplus. Loading by Pay Loaders is a necessary consequence of rail movement rationalisation also. Efforts are under way to deploy these workers to the extent possible.

- (c) CIL conducts annual pithead stock measurement in respect of each mine of every subsidiary. The details of shortfall in Bharat Coking Coal Ltd. during 1993-94, 1994-95 and 1995-96 are 0.99 million tonnes (MTs), 2.81 MTs and 0.28 MTs respectively. Where shortages in stocks are exceeding the permissible limit of measurement error of 5% with respect to book stock in pitheads, they are reported and investigated into. The existence of shortages do contribute to the loss incurred by BCCL.
- (d) and (e) Disciplinary action has been initiated in 51 cases for stock shortages in BCCL.
