Turnover data as collected and compiled by the Expert Group of the Standing Committee appointed to review the Drugs Policy, 1986, for the year 1989-90 and Retail Trade Data as available from ORG, March, 1990 has been utilised for the purpose of determining list of price controlled drugs by application of criteria laid down in 'Modifications in Drug Policy, 1986', across the board to have transparency and objectivity".
