- (iv) Employment Assurance Scheme (EAS).
 - (v) Indira Awaas Yojana (IAY).
- (b) A statement showing the physical and financial achievements under these programmes during the last three years as also for the current year, State-wise, is given in Annexures [See Appendix, 176 Annexure Nos. (19) to (23)]
- (c) and (d) No such case of diversion of funds from poverty alleviation programmes to other purposes has come to the notice of the Govt.

Low Level of Floor Price of Copra

- *68. SHRI JOY NADUKKARA: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether Government are aware that the coconut cultivators of Kerala are aggrieved with the decision of the Central Government fixing the floor price of copra at a lower level;
- (b) the criteria for fixing the floor prices for commodities;
- (c) whether (his criteria has been applied in the case of copra also;
- (d) whether Government reconsider the request of State Government of Kerala to floor price for copra; and
- (e) whether Government are likely to fix the support price for coconut oil?

THE MINISTER OF RURAL AREAS AND EMPLOYMENT AND THE MINISTER OF AGRICULTURE (DR. JAGANNATH MISHRA): (a), Yes, it has been reported that coconut cultivators are not satisfied with the Government decision on the Minimum Support Price of Copra for the 1996 Season.

(b) The Government decides on the Minimum Support Prices for various agricultural commodities taking into account the recommendations of the Cdmrtiissi6n for Agricultural Costs and Prices (CACP), the views of the concerned State Governments and the Central Government Ministries as well as such other relevant factors which, in the opinion of the Government, are important for fixation of the support-prices.

(c^ Yes, Sir.

- (d) The Government announced the price policy for copra for 1996 season on 1.2.1996 after taking into account all the relevant factors including the opinion of the State Governments.
- (e) The Government of India does not fix any support price for coconut oil.
