THE MINISTER OF STATE IN THE MINISTRY OF RURAL AREAS AND EMPLOYMENT (DEPARTMENT OF **EMPLOYMENT** RURAL AND POVERTY ALLEVIATION) (SHRI VILAS BABURAO MUTTEMWAR): (a) District-wise information on wells constructed under Million Wells Scheme is not maintained at the Central level. The number of Well constructed in Andhra Pradesh and Maharashtra under the scheme during the last three years is as under:

(b) Prior to 1.1.1996, the Million Wells Scheme was implemented as a subscheme of Jawahar Rozgar Yojana. A certain proportion of funds under JRY was earmarked for Million Wells Scheme. To boost the implementation of the scheme, the Government has taken a decision to restructure and streamline the Jawahar Rozgar Yojana. As a result, from 1.1.1996, the MWS has been

delinked from JRY and made an independent scheme.

(a) Andhra Pradesh was allocated a sum of Rs. 431.25 lakhs by way of Central & UNICEF assistance for formation of 2875 DWCRA groups during 1995-96. The entire allocation has been released.

(b) to (d) Subsequently, the State Government requested for fund for taking up 25,000 additional groups during the current year. As against this, Rs. 7.50 crores has been released for taking up 5000 additional groups.
