## Removal of Garbage and Solid Waste

638. SHRI KRISHAN LAL SHARMA: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether it is a fact that removal of garbage and solid waste is at present ill-managed throughout the country;
- (b) whether it is also a fact that big chunks of land in all the big cities of the country are lying neglected and are being used as dumping ground;
- (c) whether it is also a fact many corporate houses are willing to convert these lands into green areas and also to maintain them:
- (d) if so, whether Government have approached these corporate houses for the purpose; and
  - (e) if so, the results thereof?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI RAJESH PILOT): (a) According to an estimate about 80,000 MT per day of municipal solid waste is generated in the country. About 60% of the waste is collected and disposed off, leaving a balance of 30,000 MT garbage per day as a backlog. This uncollected solid waste fills open spaces.

drains and roads causing clogging of natural drains, pollution of water sources and insanitary conditions in the urban areas.

- (b) The conventional practice followed in this country for disposal of solid wastes is through sanitary landfills which are located on waste/depression lands in and around cities and these lands once reclaimed are used for various purpose like development of green belts and parks.
- (c) No such proposal has been received by the Government so far.
  - (d) and (e) Do not arise.

## Use of Official Language in the Central Government Offices

- 639. CHAUDHARY HARMOHAN SINGH: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether the use of official language in the Ministries/Departments/Offices of the Central Government could not be ensured despite the legal provisions in this regard;
- (b) whether the Ministries/Departments of Central Government could not achieve the targets fixed by the Department of Official Languages for the effective use of Hindi: and
- (c) if so, what steps are being taken by Government to ensure the achievement of targets fixed by the Department of Official Languages?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI RAM LAL RAHI): (a) and (b) It would not be correct to say that despite legal provisions, Ministries/ Departments/Offices of the Central Govt, could not insure the use of Official Language, since the progressive use of Hindi is increasing by implementing the O.L. Policy through goodwill, inspiration and incentives. All Ministries/Departments have been making efforts to achieve the targets fixed in the Annual Programme issued by the Department of Official Language effecting improvement in the implementation of O.L. Policy.

(c) Deficiencies in achieving the fixed targets and adopting corrective measures therefor are brought to the notice of the Ministries/Departments concerned from time to time.
