मानव संसाधन विकास मंत्रालय (शिक्षा विभाग और संस्कृति विभाग) में राज्य मंत्री (कुमारी शैलजा) : (क) से (घ) नवोदय विद्यालय समिति ने सूचित किया है थू उत्तर प्रदेश में एटा जिले के लिए भरगोल "एस" के एक नवोदय विद्यालय खोलने हेतु समिति द्वारा कोई प्रस्ताव अनुमोदित नहीं किया गया है। समिति को उत्तर प्रदेश के एटा जिले में भरगीन में एक नवोदय विद्यालय खोलने के लिए एक प्रस्ताव प्राप्त हुआ था किन्तु बाद में तकनीकी कारणों से स्थल को बदल दिया गया था।

Transfer of some CPWD Services to NDMC

864. MAULANA OBAIDULLAH KHAN AZMI: Will the Minister of URBAN AFFAIRS AND EMPLOYMENT be pleased to state:

(a) whether it is a fact that some of the services of Central Government colonies in Delhi have been handed over by CPWD to NDMC;

(b) if so, the details in this regard;

(c) the services handed over by CPWD to NDMC in respect of the New Delhi-1 area;

(d) whether NDMC is attending to those services/problems properly and satisfactorily; and

(e) if so, the details in this regard and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN AFFAIRS AND EMPLOYMENT (DEPTT. OF URBAN EMPLOYMENT AND POVERTY ALLEVIATION (SHRI S.S. AHLUWALIA): (a) Yes, Sir.

(b) and (c) The following services in Government colonies have been handed over to the NDMC:

I. ROADS:

(i) Colonies on Shahjahan Road, Humayun Road, Pandara Road, Kaka Nagar, Bapa Nagar, Rabindra Nagar, Bharti Nagar, Tilak Lane, South Avenue, North Avenue, Newly constructed colonies/quarters in DIZ Area. All circula-

tion roads, roads around parks have been handed over to NDMC for maintenance. However, the approach to the stair-case and garages are being maintained by the CFWD.

(ii) Lodi Colony, Laxmibai Nagar, East Kidwai Nagar, West Kidwai Nagar, Netaji . Nagar, Sarojini Nagar. The main feeding roads are already with the NDMC; however, the roads in front and at the back of the houses are still with the CPWD and have not yet been handed over to the NDMC.

(iii) Moti Bagh:— In this colony, the roads are being maintained by the NDMC and but the backlanes are still with the CPWD.

II. PARKS:

All the parks are with CPWD and are being maintained by them. However, for the purpose of maintenance, parks of two Government colonies, i.e., Bharti Nagar and Rabindra Nagar were transferred in 1995 initially for a period two years to the NDMC.

III. WATER SUPPLY, DRAINAGE, SEWAGE:

The external services are being maintained by the NDMC whereas the internal ones are maintained by the CPWD.

(d) and (e) Yes, Sir. The NDMC is doing regular carpetting/resurfacing work on roads, which stand transferred to them. Likewise the maintenance of sewer and water mains upto the boundaries of Government bungalows and flats is being looked after by the NDMC.

There have been complaints regarding inadequate water supply (both quantity and pressure), chockage of sewere lines and non-removal of garbage and the matter had been taken up from time to time with the NDMC by the CPWD. Funding of Hizbul Mujahideen and Other Militant Outfits in Jammu and Kashmir
