Shri Cliitra Medical Science Centre, Trivandrum

848. SHRI THENNALA BALAKRISHNA PILLAI: Will the PRIME MINISTER be pleased to state:

(a) whether Government have any proposal for the development of Shri Chitra Medical Science Centre, Trivandrum;

(b) if so, the details thereof; and

(c) how much fund has been allotted for the same?

THE MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE AND MINISTER OF STATE IN DEPARTMENTS OF ATOMIC ENERGY AND SPACE AND MINISTER OF STATE IN THE MINISTRY OF SCIENCE & TECHNOLOGY (SHRI BHUVNESH CHATURVEDI): (a) Yes, Sir.

(b) The programmes of the Institute during the Eighth Five Year Plan aim at uniting technology and medical sciences within a single institutional framework. Sree Chitra Tirunal Institute for Medical Sciences and Technology, Trivandrum has a number of R&D programmes for the development of Blood Bags, Blood Oxygenator, Cardiotomy Reservoir, Humidifier, Blood Filter, Mediastinal Drainage System, CSF Shunt and "Chitra Heart Valve", surface modification of

implants, development of critical care devices, medical instrumentation and establishing a laboratory for tissue implants and transfer of technologies to industries for production. The Institute has also a programme for integrating social sciences with the health sciences. In hospital services, the old equipments are gradually replaced by modern equipments. The Institute has made progress in fields such as installation of MRI facilities, establishment of laser medical centre, improvement in rehabilitation services and setting up of a new division of Cellular and Molecular Cardiology. In academic programmes, Achuta Menon Centre for Health Science Studies undertakes Human Resource Development in clinical laboratory technologies, etc.

(c) DST has so far provided financial support to the extent of Rs. 49.12 crores (Plan Rs. 26.60 crores+Non-Plan Rs. 22.52 crores) from the beginning of the Eighth Plan period.

NHRC on education to children

849. SHRI RAM NATH KOVIND: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that Justice Ranganath Misra, Chairman of NHRC, has in a letter addressed to various political parties sought the assistance of all national and regional parties to ensure that provision for free and compulsory education for all children below 14 years as enshrined in Article 45 of the Constitution becomes effective;

(b) if so, whether there is any proposal to make right to education a iutidamental right to make the provision more effective and meaningful; and

(c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION) (DR. KRUPASINDHU BHOI): (a) Yes, Sir.

(b) and (c) Irt order to make provision of Article 45 of the Constitution more effective and meaningful; the National Policy on Education, as approved by Parliament in 1992, gives highest priority to universalisation of elementary education. It call for ensuring that free and compulsory education of satisfactory quality is provided to all children upto 14 years of age before we enter the twenty first century.
