## Discrimination in Installation of Water Tanks

- 754. SHRI JOY NADUKKARA: Will the Minister of URBAN AFFAIRS & EMPLOYMENT be pleased to state:

THE MINISTER OF STATE IN THE MINISTRY OF URBAN AFFAIRS AND EMPLOYMENT (DEPTT. OF URBAN **EMPLOYMENT** AND POVERTY ALLEVIATION) (SHRI S.S. AHLUWALIA): (a) and (b) No general scheme for provision of separate water tanks to the ground floor allottees of multi-storeyed Government flats has been formulated. However, based on the extent of water problem, CPWD have proposals to provide separate, water tanks to the allottees of some of the multistoreyed block of flats in Scctor-2 DIZ area. In Scctot-4 of DIZ Area, the existing common overhead terrace tanks which have become beyond economical repairs, have been replaced by individual water tanks at all the floors.

(c) The CPWD have observed that the ground floor flat allottees tend to consume more water, including for horticulture and kitchen garden purposes, with the result that the allottees of upper floors do not get their share of water. ! The provision of separate water tank for

the ground floor flat, as an experimental measure, was found to improve the availability of water to the allottees of the flats on the upper storeys.

(d) The estimated expenditure on provision of separate water connection to the ground floor in Block 9 of Albert Square as an experimental measure is about Rs. 20,000/-. There is no proposal to provide separate water tanks to other storeys in Block 9 and they will continue to draw water from the common tank.
