Efforts to attract NRI investment

(a) the special efforts initiated by Government to attract the NRI investment;

(b) whether the NRIs have requested for any special concessions in order to bring more investment and if so, what are their requirements; and

(c) what is the reaction of Government in the matter?

THE MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE (SHRI BHUVNESH CHATURVEDI): (a) to (c) Government has taken a number of steps, including permission to invest upto 100% N.R.I. equity to boost NRI investment. From time to time NRI investors and Presidents of NRI
