Study on Bidi workers in Andhra Pradesh

THE MINISTER OF LABOUR (SHRI G. VENKAT SWAMY): (a) to (d) The Labour Department of the State Government of Andhra Pradesh conducted a survey during 1995 which revealed that the number of beedi workers in the State was about five lakhs working in 7,330 beedi factories and establishments registered with the State Government.

Export of rubber

comes under Open General Licence which entitles any grower to export his produce without any restriction.
