million each to orissa, U.P. Haryana and Rajasthan a loan of US \$ 1.5 million to Bihar, to undertake diagnostic studies for reforming/restructuring the State level power sector in these States with the help of international consultants.

- (c) The restructuring exercise should help in improving the physical and financial performance of the power sector at State level and make their operations more commercial and viable.
- (d) Government of India is assisting the States in carrying out the diagnostic studies as well as in obtaining external financial assistance from agencies such as the World Bank and ODA of UK for carrying out the reform process.

The bank has further intimated that teams of senior officers from its Local Head Offices/Zonal office regularly visit branches assess the to extent implementation of bank's instructions for providing better customer service. The inspection team from the bank's Central office, while carrying out inspection and audit of branches, also examines the quality of customer service obtaining in the branches and suitable corrective action is taken, wherever warranted.
