## Sanction for Pooyamkutty project in Kerala

1217. SHRI JOY NADUKKARA: Will the Minister of POWER be pleased to state whether Government would reconsider its attitude towards Kerala in the light of the acute scarcity of electricity it is facing at present and grant sanction to the Pooyamkutty project?

THE MINISTER OF STATE IN THE MINISTRY OF POWER (SHRIMATI URMILA BEN **CHIMANBHAI** PATEL): The Pooyamkutty hydroelectric Power Project in Kerala (2×120 MW) was accorded techno-economic clearance by the Central Electricity Authority in 1984 at an estimated cost of Rs. 250 crores. The project was accorded investment clearance by the Planning Commission in August, 1986 subject to the State Government's obtaining the forest clearance. Environmental clearance to the Pooyamkutty Hydroelectric Power Proiect in Kerala was accorded by the government of India in June, 1985. however, the proposal for the forest clearance was rejected in January, 1991. The State Government has represented to Ministry of Environment & forests for a re-examination of the earlier decision under the Forest (Conservation) Act, 1980.

## Power Policy for north-Eastern region 1218. SHRI PARAG CHALIHA: SHRI GOVIND RAM MIRI:

Will the Minister of POWER be pleased to state:

(a) whether Government have formulated any power policy for the North-

Eastern Region as a whole; and

(b) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF SATE IN THE MINISTRY OF POWER (SHRIMATI URMILA BEN CHIMANBHAI PATEL): (a) and (b) The Report on Perspective of National Power Development upto 2006-07 prepared by the Central Electricity Authority (CEA) provides an important input for formulation of power policy. As per this report, the Peak Demand and Energy Requirement of North Eastern Region is anticipated to be 3231 MW and 15319 MUs respectively. Considering the high hydro potential the total installed generating capacity requirement is assessed at 4480 MW by the end of the above period. The report also suggests Demand Management Strategy and several supply side options including **Energy Conservation to augment capacity** requirement in the region.

## World Bank's scheme for State Electricity Boards
