THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI KUKH RAM): (a) to (d) As per the terms of reference set for it by the Government the Khan Committee was required to make recommendations for making the Deptt. Telecommunications more connective. efficient and customer friendly through improved performance so as to effectively compete with the private sector. The recommendations of the Committee which are in keeping with its terms of reference are under consideration of the Government. In making recommendations for privatisation of the Deptt. of Telecom the Committee exceeded its brief and as such it is not proposed consider to anv recommendations made by the Committee beyond its original terms of reference.
