Progress in merging Indian Airlines and Air India

Appointment of Joint Chairman and common Board of Directors will facilitate desired level of integrated functioning.

(b) The management of both the airlines have been negotiating with the respective Unions/Associations/Guilds the level of wage increase and the associated increase in productivity.
