SHRI E. BALANANDAN (Kerala): Madam, first a House Committee should be appointed. (Interruptions)

SHRI SATYA PRAKASH MALAVIYA (Uttar Pradesh): We want a House Committee, Madam. (Interruptions)

SHRI NILOTPAL BASU (West Bengal): Madam, we want to know whether an inquiry will be held or not. (Interruptions)

SHRI E. BALANANDAN: We want a House Committee, Madam. ... (Interruptions)...

THE DEPUTY CHAIRMAN: If you like... (Interruptions) Just one second. (Interruptions) You see, I can't ... (Interruptions) You can discuss it in my chamber. (Interruptions) I invite all of you to come and discuss it there, (interruptions) You have do discuss the matter. (Interruptions) This is not the way. (Interruptions) A House committee cannot be appointed by coming to the well, I can assure you. (Interruptions) This is no procedure. (Interruptions) No. This is no procedure.
