SHRI V. NARAYANASAMY: Madam, I do not know how this is being allowed to be raised, when the matter is pending before the Court.

SHRI CHATURANAN MISHRA: I am not raising the matter. I am only asking her to move in the Supreme Court to dispose of the case before the elections.

SHRI V. NARAYANASAMY: Madam, the Government has been giving all assistance. (Interruptions)

SHRI CHATURANAN MISHRA: Cabinet Ministers are involved. That is why I am asking this much. (Interruptions)

THE DEPUTY CHAIRMAN: Nothing is going on record now. Please sit down. I am not allowing this because you cannot take names of persons who are not here and who cannot defend themselves.

SHRI CHATURANAN MISHRA: I have not said any name.

THE DEPUTY CHAIRMAN: I have heard one name. Mr. Salim mentioned one name. We should not talk about people who are not present here in the House and who cannot defend themselves. Making allegations is one thing. She has replied as she could reply. She said that the matter is pending in the court. But, just getting up in the House and throwing mud at each other is not going to lead us anywhere.

DR. BIPLAB DASGUPTA: Let them say that they have not taken money.

THE DEPUTY CHAIRMAN: Dr. Biplob Dasgupta, she has mentioned the whole thing peacefully and he has also mentioned about it. This is the forum and this is your right to mention. But, Mrs. Alva has said that the matter is before the Court and let the court decide it. If the matter had not gone to the court, the House would have decided. The matter is there now. If you suggest that somebody

should come and say, it is your viewpoint. Now, let me go ahead, because only three minutes are left before we adjourn for lunch. I am only bothered about the House. (Interruptions) There has been misappropriation of the time. Against whose quota should I put it?

SHRI CHATURANAN MISHRA: Madam, it is not that since the matter is *sub judice*, we cannot ask for moving the court to have it disposed of before the elections.

Demand for Autonomous development Council for Western Orissa

SHRI SANATAN BISI (Orissa): Madam, in the year 1969, the National Council for Applied Economic Research had made a survey of the backward and Western districts of Orissa and had remarked "Socially and economically, the Western region of Orissa, constitutes the most backward part of the State. Such backwardness is characterised by low income levels, higher dependence of population on poorly developed

agriculture, large proportion of population belonging to scheduled Tribes and lack of basic infrastructure for development."

I may mention here that the promise for formation of Western Orissa Development Council found a place in the election pledge of the Congress Party during February 1995. I draw the attention of the senior Ministers and Members of the Congress, those who are present in the House, that our Prime Minister, Shri P.V. Narasimha Rao during his election campaign in February, 1995, had assured us the formation of a Regional Development Council for Western Orissa. Again for the second time, at a public meeting on 29.6.1995 at Banharpali, District Jharsuguda, Orissa, he had repeated the same assurance.

The Government of Orissa has not yet taken any positive steps in this direction and the people of that region are on their way to create an awareness in support of their demand.

It is high time that the Centre issued necessary instructions to the Government of Orissa to introduce a Bill in the Assembly for the formation of a Western Orissa Autonomous Development Council with the following provisions:—

"To provide for the establishment of the Western Orissa Autonomous Development Council and for certain matters incidental thereto for the economic, social, educational and cultural development of the people of the region."

They wanted to raise some issues. They are equally important for the people. Now these have gone. Tomorrow we may not have it. These would come only on Friday.
