- (c) and (d) Hindon airfield has been identified as "high risk bird area" in the country by an Interministerial Joint Subcommittee, which recommended following measures:-
 - (i) Clearance of approach zones outside the airfields.
 - (ii) Construction modern incinerators.
 - (iii) Construction of modem slaughter houses.
 - (iv) Construction of modern carcass processing centres.
 - (v) Shifting of open garbage dumps from the vicinity of airfields.
 - (vi) Covering of open drains.
 - (vii) Establishment of covered fish and meat markets.
 - (viii) Construction of covered garbage points.

Airfields Environment Management Committee meetings are held regularly under the Chairmanship of the District Magistrate of the concerned State in which the IAF airfield is located to maintain cleanliness around the airfield. Necessary measures have also been taken by the Ministry of Agriculture, Ministry Development of Urban and the concerned State Government modernise slaughter houses and carcass utilisation centres so as to sanitise areas around the airfields identified by the Inter-Ministerial Joint Sub-Committee.
