#### Amendment to the Succession Act

THE MINISTER OF STATE IN THE MINISTRY OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI H. R. BHARDWAJ): (a) Government of Kerala has a proposal to amend the Indian Succession Act, 1925 in its application to the State of Kerala for the purpose of excluding the Christians from the requirement of obtaining probate of a will. The said proposal which has been referred to the Central Government is receiving its attention.

(b) The question of undertaking any Parliamentary Legislation for amending the Indian Succession Act, 1925 will be considered by the Central Government as and when the necessary initiative from the Christian Community is received in this regard.
