#### **Villages under deep poverty**

533. SHRI V. HANUMANTHA RAO: Will the Minister of RURAL AREAS AND EMPLOYMENT be pleased to state that the number of villages under deep poverty in the country, State-wise, and the number of the families residing in those villages?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL AREAS AND EMPLOYMENT (DEPARTMENT OF RURAL EMPLOYMENT AND POVERTY ALLEVIATION) (SHRI VILAS MUTTEMWAR): According to Planning Commission, estimates of incidence of poverty are prepared at the State level and no estimates of incidence of poverty are made at the village level. Hence the estimates of the number of villages under deep poverty as also the number of families residing in the villages are not available.

#### **Proposal to set up industries in Orissa during Eighth Plan period**

535. SHRI BHAGABAN MAJHI: Will the Minister of INDUSTRY be pleased to state:

(a) the number of major and medium industries proposed to be set up in Orissa during Eighth Plan;

(b) the break-up of those proposed projects public sector, private sector and joint sector-wise; and

(c) the places identified for the establishment of those units?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (DR. C. SILVERA): (a) to (c) No targets for setting up industries during 8th Five Year Plan for Orissa have been fixed. Most of the industries are delicensed and during 8th Five Year Plan period (April 1992 to October, 1995) 116 Industrial Entrepreneurs Memoranda have been filed for delicensed sector for locating industries in Orissa. For licensable sector, a total number of six Letters of Intent have been granted under the Provisions of Industries (Development & Regulation) Act during the same period for setting up various industries in Orissa. Out of these one Letter of Intent has been granted for Central Public Sector and the rest are for private sector. The locations are in Ganjam, Paradeep, Jajpur and Balasore districts.
