## Wrong Exclusion of Drugs

## 634. SHRI RAJNI RANJAN SAHU: SHRI GOVINDRAM MIRI:

Will the Minister OF CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether Government have received representations against wrong exclusion of Triprolidine, Tinidazole, Vitamin B6, Zink Bacitracin, Glybenclamide, Diphenoxylate Hcl, Hamaccel, Foot and Mouth Diseases Vaccine, Rabipur Polymixin Vaccine, В Sulphate etc. formulated mostly multinational bv companies;
- (b) the names of companies marketing these medicines;
- (c) the time of receiving representation in each case and the action taken in this regard;
- (d) the reasons for excluding these drugs and the names of the bulk drugs to which the criteria approved by the Cabinet was applied; and
- (e) the drugs to which criteria was not applied on the ground that details of turn over were not available?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND **FERTILIZERS** (SHRI **EDUARDO** FALEIRO): (a) In certain to (c) representations for exclusion of a drug from price control, some manufacturers, in order to support their claim, have cited instances of other drugs which are not under price control and have given the opinion that it is wrong. However, no authentic data has been furnished by them to substantiate the same. All the representations are at an advanced stage of consideration.

(d) and (e) List of drugs kept under price control has been prepared on the basis of criteria laid down in the 'Modification in Drug Policy, 1986' by applying it across the board to the data collected and compiled by the expert group. Drugs which did not either have

monopoly situation, if the turnover was more than Rs. 100 Lakhs or had market competition, if the turnover was Rs. 480 Lakhs or more, are out side price control.
