THE MINISTER OF STATE IN THE OF MINISTRY **AGRICULTURE** (SHRI ARVIND NETAM): (a) The National Pulses Development project is being implemented in the States of Andhra Pradesh, Arunachal Pradesh. Assam, Bihar, Goa, Gujarat, Haryana, Himachal Pradesh, Jammu & Kashmir, Madhya Pradesh, Karnataka. Kerala. Maharashtra. Manipur, Meghalaya, Nagaland, Orissa, Punjab, Rajasthan, Sikkim, Tamil Nadu, Tripura, Uttar Pradesh, West Bengal, Delhi and Union Territory of Andaman & Nicobar Islands.

- (b) As a result of implementation of National Pulses Development Project the production of pulses has shown considerable improvement. The production has increased from 12.02 million tonnes in 1991-92 to 14.46 million tonnes in 1994-95 which is an all time record.
- Under National Pulses (c) Development Project, assistance provided to the farmers on production and distribution of seeds, distribution of improved farm implements, sprinkler sets, Dal processors and storage bins, Rhyzobium culture, Micro-nutrients, retail outlets and Pheromone Traps. production technologies Further, being disseminated through frontline

demonstrations being organised by Indian Council of Agricultural Research(ICAR) and Block and Integrated Pest Management(IPM) demonstrations are being organised by the State Department of Agriculture. The farmers are provided the basic inputs to organise these deomonstrations.
