Statement on AIDS in India

485. SHRI INDER KUMAR GUJRAL: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that according to an announcement made by Prof. Rager Short of Monash Unviersity, Melbourna in the Conference titled Australian Foreign Ecologically Sustainable Population, India will be worst affected AIDS region in five years time;
- (b) whether Government have examined the basis of the aforesaid statement made by Prof. Short; and
- (c) the steps Government are contemplating to meet the explosion likely to be caused in the field of AIDS?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI A.R. ANTULAY): (a) and (b) A news item to this effect has appeared in the Pioneer, New Delhi, dated March 5, 1995. The Statement attributed to Prof. Rager Short could at best, be his assumption.

(c) In order to prevent and control the spread of HIV /AIDS in India a comprehensive programme is currently under implementation as a centrally sponsored scheme throughout the country. The strategies the programme consist of generation of awareness amongst high risk behaviour groups and general public about HIV/ AIDs, control of Sexually Transmitted Diseases, Blood Safety and rational use of blood, better survellance; diagnosis and Clinical Management of HIV/AIDS cases.

 - 4. Proper testing was not carried out.
