Industrial and Financial Reconstruction (BIFR on 21.9.95, the BIFR . had generally suggested that the Government might consider merger of loss making units of the Fertilizer Corporation of India Ltd. (FCI) with other public sector units while formulating the revival package for FCI. Accordingly at the time of tying up funds for fresh investment in FCI as per the revival package the Government had explored the possibility of merger of some of the units of FCI with cash surplus public sector enterprises (PSEs). However, no PSE had evinced interest in the proposal. Government has brought this to the notice of B.I.F.R.

#### Formulation of New sports policy

- 609. SHRI IQBAL SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) whether Government have fomulated any new sports policy in the country;
  - (b) if so, the details thereof;
  - (c) if not, the reasons therefor; and
- (d) what steps are being taken by Government to make sports'NCC compulsory in school and colleges in the country?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF YOUTH AFFAIRS AND SPORTS) (SHRI MUKUL WASNIK): (a) to (c) No, Sir. However, it has formulated a programme of action for the existing National Sports Policy (1984) which was placed in both the Houses of Parliament in August 1992. The thrust areas identified in this programme of action are as follows:

- (1) Creating a sports environment;
- (2) Broadcasting of sports;
- (3) Improving competitive standards;
- (4) Improving standards of sports management.
- (d) The Government have taken a number of steps to promote sports in schools and colleges. The Central Advisory Board of Education (CABE) has recommended to make sports and physical education a compulsory subject in schools and colleges. Following are the salient recommendations of CABE for which the States/UTs have been advised to take appropriate action:—
  - (i) physical education and spprts should be made a compulsory part to curriculum and assigned at least 40 minutes everyday for all school going children. A system of evaluation may also be prescribed to assess the fitness and overall participation of the children in physical education and sports throughout the year.

- (ii) Subject teachers may be trained as physical education teachers through pre-service and in-service training courses.
- (iii) The State Government may make their contribution to a sports fund for creation of sports infrastructure in the schoolstolleges within the State.
- (iv) Mass participation activities and sports competitions may be organised by all State Governments regularly for schools and colleges,
- (v) In schools and colleges where performance in academics is the criterion for admissions, special weightage may be considered to be given to sports persons who have excelled.
- (vi) State Government may identify at least one school per District as a Sports School for nurturing of talented sprotspersons.

There is no proposal to make NCC compulsory in schools and colleges.
