(d) The percentage of special dispensation admissions comes to 13.95%. In view of the large demand the Chairman, Kendriya Vidyalaya Sangathan decided to accord permission for admissions beyond 10 per cent.

#### Construction of Steel Yard

Will the Minister of STEEL be pleased to state:

(a) the progress made in the construction of the steel yard for the Steel Authority of India Ltd. at Cochin;

(b) when the construction was started;

(c) whether there is any delay in the construction of this yard;

(d) if so, the reasons therefor; and

(e) by when this yard is likely to be operational?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV): (a) to (e) The development work for the new stockyard at Cochin was started in October, 1991. All the work except black topping, railway siding and finishing work of building have already been completed. Balance civil engineering work has been suspended since September, 1993. Recently, due to certain dispute relating to earth/sand filling Quantities with M/s. Richardson & Cruddas (main contractor), their sub-contractor has filed a civil suit in Madras High Court, and the matter is subjudice. Once the work is resumed, it is expected that it will take about 6 months time to complete the balance work after which the yard will become operational.
