Market Survey by ITPO in South Africa

- SHRI CHIMANBHAI HARI-BHAI SHUKLA: Will the Minister of COMMERCE be pleased to state:
- (a) whether the Indian Trade Promotion Organisation (ITPO) has recently concluded a market survey in South Africa;
- (b) if so, the itemes identified as a result of this survey and possibility of organising trade development programmes such as trade fairs and exhibitions, investment, joint venture to strengthen bilateral trade and economic cooperation between the two countries; and
- steps the being taken Government in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF COMMERCE (SHRI P. CHIDAMBARAM): (a) Yes, Sir. India Trade Promotion Organisation conducted a market survey in South Africa in January, 1994.

(b) The survey has identified following items for export to South Africa:-

Garments, textiles, home furnishings made-ups, rice, beans, lentils, spices, coffee. computer software and hardware, sports and exercise bicycles, handtools and machine tools, agricultural implements and diesel pumping sets, builders' hardware including bathroom and sanitary fittings, electrical fittings, industrial surgical and medical fasteners, equipments, stuffed toys, handicrafts, utility-cum-dccoratives, leather goods, footwear, forgings & castings, bulk drugs, chemicals & dyes and earth moving equipments.

The surveys has also dealt with the possibility of organising exclusive Indian Exhibition or participating in some trade fairs in South Africa such as SAITEX in

addition to exploring the possibilities of investment, setting up joint ventures and strengthening bilateral trade economic cooperation between the two countries on a long term basis.
