CHANDRASHEKHAR MURTHY): (a) and (b) The Government have, in a few found evidence instances declaration of export value of goods exported to Russia. No evidence has so far been unearthed to indicate that the money has been kept in secret bank accounts in Western Europe and remitted back as proceeds of exports to Russia.

The Government Enforcement Agencies are vigilant against the such occurrence of malpractices. Appropriate action would be taken against the offenders whenever such cases are detected.
