(ख) यदि हां, तो क्या गत वर्षों में देश में विदेशी ऋण की प्रति व्यक्ति औसत राशि, अन्य देशों की तुलना में सबसे कम है; और

(ग) यदि नहीं, तो तत्संबंधी तथ्य क्या हैं?

(ख) जी, हां। विश्व बैंक द्वारा प्रकाशित विश्व विकास रिपोर्ट, 1995 के अनुसार निम्न आय वाली अर्थव्यवस्थाओं में वर्ष, 1993 में प्रति व्यक्ति सरकारी विकास सहायता की प्राप्तियां भारत के लिए 1.7 अमरीकी डालर, चीन के लिए 2.8 अमरीकी डालर, नाइजीरिया के लिए 2.7 अमरीकी डालर, पाकिस्तान के लिए 8.7 अमरीकी डालर और म्यांमार के लिए 2.3 अमरीकी डालर थी।

Appointment of Executive Directors by Stock Exchanges

Will the Minister of FINANCE be pleased to state:

(a) whether appointment of Executive Directors by the Stock Exchanges made mandatory by any legislation, if so, the details thereof;

(b) whether Guwahati Stock Exchange (GSE) has invited applications for Executive Director during the last three years, if so, dates of advertisement with names of newspapers;

(c) names and addresses of the applicants with their present occupation;

(d) whether any short-listing of applicants has since been done, if so, names of such applicants;

(e) by when GSE propose to complete process of appointment; and

(f) whether Government propose to have its nominee(s) on selection committee if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (DR. DEBIPROSAD PAL): (a) No, Sir.

(b) Guwahati Stock Exchange has issued three advertisements inviting applications for the post of Executive Director in that Exchange since August, 1993. The dates of advertisements and the names of the concerned newspapers are given in the statement (*see below*).

(c) The information is being collected and will be laid on the Table of the House.

(d) Yes, Sir. The names of the candidates shortlisted earlier by the Exchange are given in statement II (*see below*). Applications received in response to the advertisement of October, 1995 are being processed by the Exchange for shortlisting.

(e) The Exchange proposes to complete the process of appointment of Executive Director by January, 1996.
