hours for private PCOs are 12 hours i.e. 0800 hr. to 2000 hours. However they may remain opened beyond these time limits. This applies to private PCOs outside Delhi Gate Exchange also.

(e) Though Delhi has already achieved the 8th plan target of having one PCOs for every 500 persons, provision of additional PCOs is a major thrust area.

#### Steps to Improve the image of Delhi Police

898. SHRI INDER KUMAR GUJRAL: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that in the last couple of months, a number of Police Officers in Delhi were caught red-handed while accepting bribes or on charge of dereliction of duty, if so, what are the details thereof: and
- what steps Government contemplating to improve the image of Delhi Police in the light of these acts of corruption?

THE MINISTER OF STATE IN THE OF HOME MINISTRY AFFAIRS (PROF. M. KAMSON): (a) Yes, Sir. During the period from 1.9.95 to 31.10.95, nine police officials were caught red-handed. accepting bribes. criminal cases have been registered officials. against these police nine Besides. this. administrative action sixteen police officials for dereliction of duty during the above period has been taken.

(b) With a view to curbing involvement of policemen in crime and generating public confidence, the Delhi Police has been taking deterrent action against errant officials. This include disciplinary proceedings in all cases where policemen are found involved in crimes. Besides, Delhi Police are revising the training syllabus, both of initial training and refresher courses, to bring about the required behavioural changes among policemen. Briefing is also being given by senior officers to the members of the

force through Sampart Sabhas. Emphasis is being placed on accessibility of senior officers to the public. A close watch is being kept on the conduct of policemen with doubtfull integrity, by the Vigilance Branch and the Anti-Corruption Branch of the Government of National Capital Territory of Delhi.

### Progress of Sethu Samudran Project

- 899. DR. D. MASTHAN: Will the Minister of SURFACE TRANSPORT be pleased to state:
- (a) what is the progress made in respect of Sethu Samudran Project submitted by Tamil Nadu Government which involves excavation of a canal to connect Palk Strait with the Gulf of Mannar to facilitate passage of ships; and
- (b) what are the reasons for the delay in approving the project?

THE MINISTER OF STATE OF THE OF SURFACE MINISTRY TRANSPORT (SHRI M. RAJASEKARA MURTHY): (a) and (b) Due to financial constraints the Sethu Samudran Project could not be included in the 8th Five Year Plan.

## Faulty Radio Telephone Service in Tamil Nadu

- 900. DR. D. MASTHAN: Will the Minister of COMMUNICATIONS be pleased to state:
- (a) whether Government are aware that radio telephone set up in several villages of Tamil Nadu have failed because of the poor audio-quality; and
- (b) what steps Government have taken to provide telephones to all the villages in the State?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATION (SHRI SUKH RAM): (a) Sir, the radio telephone set up in the villages of Tamil Nadu have been maintained in good condition and the audio quality is satisfactory.

## Granting approval for imports to Pepsi Foods Limited

# 901. SHRI N. GIRI PRASAD: SHRI MISA R. GANESAN: SHRI V. NARAYANASAMY:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the approval granted to M/s. Pepsi Foods Limited by Government permits the value of its exports to be taken into account for purposes of imports by M/s. Pepsi Company India Holdings and its subsidiaries:
- (b) whether M/s. Pepsi Company India Holdings and its subsidiaries have given any undertaking of commitment to Government that they would export three times the value of their imports;
- (c) whether any items imported by M/s. Pepsi Company India Holdings and its subsidiaries have been sold to M/s. Pepsi Food Limited; and
  - (d) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD PROCESSING INDUSTRIES (SHRI K. P. SINGH DEO): (a) As per the approval granted for M/s. Pepsico India Holdings, import of capital equipment, components and raw materials by it will be allowed as per the import policy prevailing from time to time. No condition has been imposed in this approval regarding the ratio of exports to imports. The separate approval granted to M/s. Pepsi Food Limited stipulates that export to import ratio shall all along be maintained at 3: 1.

(b) In connection with some approvals granted under the Import Policy, Pepsico

- India Holdings has undertaken to export three times the value of imports covered by such approvals.
- (c) The Company has stated that no items have been imported by M/s. Pepsico India Holdings and its subsidiaries and sold to M/s. Pepsi Foods Limited.
- (d) Does not arise in view of answer to (c) above.

#### Orissa Maritime Academy

- 902. SHRI PRAVAT KUMAR SAMANTARAY: Will the Minister of SURFACE TRANSPORT be pleased to state:
- (a) whether Government are aware that there is Orissa Maritime Academy, Paradeep to train the boys from different parts of the country to be the Seamen for different Shipping Companies:
- (b) whether Government are also aware that about one hundred candidates after successful completion of training could not get employment even though some of them are sponsored by Shipping Companies because of the threat from NUSI (Bombay) to Shipping Companies; and
- (c) if so, what action Government contemplate to protect the interests of these trained boys from a Government sponsored institution?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI M. RAJASEKARA MURTHY): (a) Yes, Sir.

- (b) As per the prescribed procedure, the candidates selected for training in the Rating Training Establishment should be sponsored by the Shipping Companies. Since the candidates selected for training by the Orissa Maritime Academy had not been sponsored by Shipping Companies before their selection, some of them are facing employment problem.
